

#### Administration

- The meeting agenda was revised to include discussion of the Community Sector Council's "Policy on the Rock" virtual conference.
- Deferred minutes for the Partnership Table meetings held on the following dates were approved:

### **Updates & Reports**

- 1. Standing Committees
  - All four Standing Committees are in the process of identifying additional stakeholders beyond members of the Partnership Table to support the development of objectives in each priority area to be included in the coalition's Community Action Plan.
- 2. MMIWG Project
  - The Working Group convened its second meeting on Friday, February 26, 2020. Going forward, regular meetings will take place on the last Thursday of each month.
  - The Legal Research Intern has completed a draft legislative review and has begun work on an environmental scan of other jurisdictions. Both documents will help to inform the ongoing development of the Working Group's Terms of Reference as well as an interim report, a draft of which is expected by mid-summer.

#### **Regular Business**

- 1. Food First NL's St. John's Food Assessment Project
  - Following its presentation to the Partnership Table on January 13, 2021, Food First NL has extended an invitation to First Voice to participate in the Working Group that is leading the St. John's Food Assessment Project.
  - It was agreed that First Voice should work to support the urban Indigenous community's access to both healthy and traditional foods. It was further agreed that all such work is best coordinated through the Health and Wellness Committee.
  - IT WAS DECIDED THAT the Health and Wellness Committee will designate one of its members to participate in the St. John's Food Assessment Project's Working Group on behalf of First Voice.
- 2. "Policy on the Rock" Virtual Conference
  - The Community Sector Council will be hosting a virtual policy conference on March 29, 2021. Titled "Policy on the Rock," the purpose of the conference is to explore intersections between health, food, and poverty reduction.

- The Keynote Address will be delivered by Sister Elizabeth Davis, Co-Chair of the provincial Task Force on Health Care (also known as Health Accord NL). Her address will focus on the social determinants of health.
- Following the Keynote Address, a panel of discussants will have an opportunity to add further context and perspective. Conference organizers are working to identify discussants from diverse backgrounds, including from the Indigenous community, and have extended an invitation to First Voice to participate.
- IT WAS DECIDED THAT First Voice will participate in the panel discussion and that the coalition would best be represented by one of its six Community Advocates. Stacey Howse will coordinate with conference organizers and Community Advocates to work out the details of First Voice's participation.
- 3. Indigenous Advocate Award 2021 Nominations Committee
  - In line with the parameters agreed at the Partnership Table meeting held on February 3, 2021, the Nominations Committee for the 2021 Indigenous Advocate Award will be responsible for overseeing the award process. This includes reviewing and evaluating nominees, identifying a short-list of nominees, and selecting the final recipient.
  - It was agreed that the Nominations Committee should include a diverse range of Indigenous and non-Indigenous perspectives and identities. It was further agreed that the committee should consist of 6 or 7 members, with a majority of members identifying as Indigenous.
  - IT WAS DECIDED THAT First Light will lead the process of identifying suitable members to serve on the Nominations Committee. First Light will also be responsible for constituting and convening the committee on behalf of First Voice.
- 4. Community Action Plan 2021-30
  - To help inform the content and format of First Voice's own Community Action Plan, the Partnership Table reviewed examples of those that have been adopted in other jurisdictions, such as Halifax, Lethbridge, Regina, Ontario, and Surrey.
  - It was suggested that the final Community Action Plan may include the following elements:
    - A Gap Analysis that (1) articulates the specific needs that exist in each priority area; (2) recognizes organizations that are already doing similar or related work; (3) identifies work that is not yet being done by anyone;

and (4) lists any stakeholders and/or decision-makers that will need to be engaged going forward. (Halifax's Community Strategic Plan was cited as an example.)

- Cross-functional "Action Areas" to help coordinate work on complex sets of objectives that engage more than one priority area, such as those related to challenging systemic racism. (Ontario's Urban Indigenous Action Plan was cited as an example.)
- Key Performance Indicators (KPIs) that clearly identify how and when progress made toward each objective will we measured and reported. (Ontario's Urban Indigenous Action Plan was cited as an example.)
- A holistic and balanced approach that identifies both what is currently working and what needs to be improved. (Ontario's Urban Indigenous Action Plan was cited as an example.)
- In addition, it was further suggested that the Community Action Plan should combine policy analysis with human-focused storytelling in order to highlight not only what needs to change but also why change is needed. (The approach used during the facilitated sessions at the Decolonize YYT conference was cited as an example.)
