Administration

• The minutes for the Partnership Table meeting held on August 5, 2020, were approved with no revisions. The document will be posted to the First Voice website.

Updates & Reports

- 1. New Premier and Cabinet
 - Andrew Furey was sworn in as Premier on August 19, 2020, and a new Cabinet was appointed later that afternoon.
 - Lisa Dempster has been appointed Minister of Indigenous Affairs and Reconciliation as well as Minister Responsible for the Status of Women.
 - o Steve Crocker has been appointed Minister of Justice and Public Safety.
 - On the same day the new Cabinet was announced, First Light's Executive
 Director, Morgan Hare, sent a letter to the new Premier on behalf of First Voice.
 The letter congratulated Premier Furey on his new position and requested a
 meeting with him to discuss First Voice's priorities. Minister Dempster was
 copied.

2. Social Media Policy

- A Social Media Policy Working Group has been formed to guide First Voice's use of social media channels. The Working Group includes the following members:

- Social media channels using the @FirstVoiceNL handle have been created on all major platforms, including Twitter, Facebook, Instagram, LinkedIn, and YouTube.
- IT WAS DECIDED BY CONSENSUS that First Voice will begin using Twitter and Facebook to share basic information about the coalition's activities and events.

3. Website Updates

- Profiles of all six Community Advocates are now available online. They can be found at firstvoicenl.ca/partnership-table/community-advocates/.
- A media release was posted to the website on September 1, 2020, to announce the appointments. The release was circulated to local media and was also shared on First Light's social media channels.

Regular Business

- 1. Memorial University's Strategic Framework for Indigenization
 - Memorial University has received extensive feedback on its draft Strategic
 Framework for Indigenization. Feedback has come from individuals, community organizations, and university units.
 - The review and approvals process will begin by having a working group review all feedback and recommend revisions. The document will then go to the Vice-Presidents' Council, the University Senate, and the Board of Regents for approval. It is expected to be adopted by December 2020.
 - Some parts of the Strategic Framework are already in the process of being implemented, such as the recent adoption of a new Indigenous research policy.
 - It was suggested that First Voice may have a role to play in supporting Memorial University's implementation of the Strategic Framework.

2. Policy Conference

- The overall purpose of the Policy Conference is to develop a collaborative Community Action Plan that will guide the work of First Voice over the next several years.
 - The conference will bring together community organizations, anti-racism practitioners, all levels of government, and faculty, staff, and students at Memorial University.
 - Expected outputs include the identification of specific objectives tied to the Calls to Action of the Truth and Reconciliation Commission, the Calls for Justice of the National Inquiry into Missing and Murdered Indigenous

Women and Girls, and the United Nations Declaration on the Rights of Indigenous Peoples.

- Because of ongoing public health restrictions related to COVID-19, it was decided at the July meeting of the Partnership Table that the Policy Conference would proceed using a virtual format.
- First Voice has retained One Page Plans, a consultancy based in Halifax, to support the design and delivery of the virtual event. This includes:
 - Designing and facilitating four three-hour sessions focused on each of First Voice's priority areas;
 - Creating a set of four conference briefs, tailored to each three-hour session, to be circulated to participants prior to the conference;
 - Designing and implementing an online form that can be used to collect supplemental input from conference participants, and possibly from the public as well;
 - o Producing a final report summarizing the results of each session.
- One Page Plans has recommended that each of the facilitated sessions include no more than 16 active participants in order to ensure that the session objectives can be achieved.
 - It was suggested that participants should be invited selectively in order to ensure a diverse group that includes those who have decision-making authority, policy expertise, lived experience, etc.
- IT WAS DECIDED BY CONSENSUS that a Conference Planning Committee will be formed to make executive decisions in relation to the conference and to provide direction to One Page Plans. The committee includes the following members:

 - Maggie Burton, City of St. John's
 - Michael Lannon, Community Advocate
 - Stacey Howse, First Light
- The Conference Planning Committee will decide whether to host public sessions as part of the conference, such as keynote speakers, panels, and/or musical performances. These additional sessions could be broadcast online before, after, and/or in between each of the four facilitated sessions.
- <u>IT WAS DECIDED BY CONSENSUS</u> that the conference will take place over two days on Thursday, November 5, and Friday, November 6, 2020.
