### **ANNOUNCEMENTS**

### 1. SIRT-NL MOU

- Justin explained that the SIRT-NL MOU had been accepted and is ready to be signed by a representative of First Voice.
  - The group nominated Community Advocate Lisa Smith to be the Signatory for First Voice. Jordan will follow up with them for confirmation.
- The group discussed possibilities for creating a 'good news story' for Urban Indigenous Peoples. Some ideas were:
  - A formal Press Release that invites local media and the community to join in a celebratory feast followed by ceremony which reflects the values of the diversity of Indigenous Peoples within the urban environment.
    - The lighting of a Kullik
    - Inuit Drumming
    - Throat Singing

- Following the Press Release there will be a photo opportunity along with Joint Media Availability to address any technical details and questions.
  - It was noted that significant attention should be given to address those who may feel skeptical about the MOU as many people are unfamiliar or misinformed around the purpose of SIRT-NL and its role in delivering Justice after a serious incident involving policerelated force, wrong-doing or death.
- An "Official Backgrounder" will be produced in plain language to facilitate community-based information sharing.
  - First Light will plan, coordinate, and collaborate with SIRT-NL to identify a schedule, and will draft the document to bring forward to the Partnership Table for review.

### 2. Indigenous Justice Action Circle (IJAC)

- The Terms of Reference have been finalized and approved by both the Partnership Table and the Indigenous Justice Action circle members.
- An update on deliverables will be provided at the next Partnership Table meeting.

### 3. Indigenous Healthcare Action Circle (IHAC)

- The Organizational Co-Chair will be Collette Smith from Newfoundland and Labrador Health Service, in partnership with Darla King, Executive Director of the Department of Health and Community Services.
- The Community Advocate Co-Chair is Brooke Blanchard, with support from fellow Community Advocate Rutanya Wynes.
- Follow-up meetings with the Co-Chairs will take place soon to determine any identified stakeholders, decision-makers, community members and rightsholders for invitation.

#### **REGULAR BUSINESS**

- Education Priorities: Moving Forward
  - Indigenous Education Advisory Committee (IEAC)
    - It was noted that our letter offering to join the IEAC had been brought to the table on October 4 & 5, 2023.
    - There has been no response since.
      - The group appreciated the time it takes to revamp any educational curriculum; however, they expressed disappointment in the lack of clarity around timelines for change, as well as the inclusion of Urban Indigenous Peoples.
  - Call for Change 1
    - The structure of the education system complicates decision-making processes related to the creation and implementation of new curriculum.
      - It was suggested that First Voice try connecting directly with the Minister of Education to facilitate more meaningful engagement with the process.
      - Support is not being built for parents who must navigate the system which is over-structured and often denies cultural learning opportunities for Indigenous and non-Indigenous students alike.
      - The process for developing new curriculum needs to be understood by the public, especially Indigenous Peoples who may be unfamiliar with how the systems work.
      - It was noted that parents need to be properly involved to accurately inform any decisions around curriculum changes.

All remaining agenda items were deferred to a future meeting.
